Additional photo editing/graphics beyond basic adjustments and cropping: \$25 per hour by ¼ hr

Re-takes because of pilot/photographer error (image of wrong subject etc.): No charge

Re-takes because of customer error or incorrect information:

The original charge plus \$25 per hour by ¼ hr

Original digital files from archives priced individually.

Ownership Rights.

(a) Photographer shall retain, under the fullest extent under the law, full copyright and interest in any and all film, digital files, proofs, samples, prints, or negatives created or produced for Customer pursuant to this Agreement.

(b) Customer agrees to return to Photographer any materials Customer may have of Photographer's such as artwork, mock-ups, comps, text, digital media, film, images, or any other physical or digital embodiment of Photographer's creative work performed under this Agreement.

(c) Upon termination or expiration of this Agreement, Customer agrees to be solely responsible for any additional use of materials and advertisements created by Photographer pursuant to this Agreement. Additional expenses may include, but are not limited to: Fees, licenses, translations, royalties, talent, and other associated fees.

(d) Customer is granted a non-exclusive worldwide right to use the materials for Customer's own promotional, advertising, internal use. Photos or materials are **NOT** to be resold or distributed to any third parties or event participants. Photographer's copyright must accompany all use of the photos or materials whenever possible and must read "Copyright 2009 by: Jerry Luther".

(e) Customer will be reimbursed for sales of "worked" images taken on commissioned photography at the rate of \$10 each sale up to a maximum of \$50.
